At Nomad Foods, we use SAP Ariba Supplier Lifecycle and Performance (SLP) to onboard our suppliers.

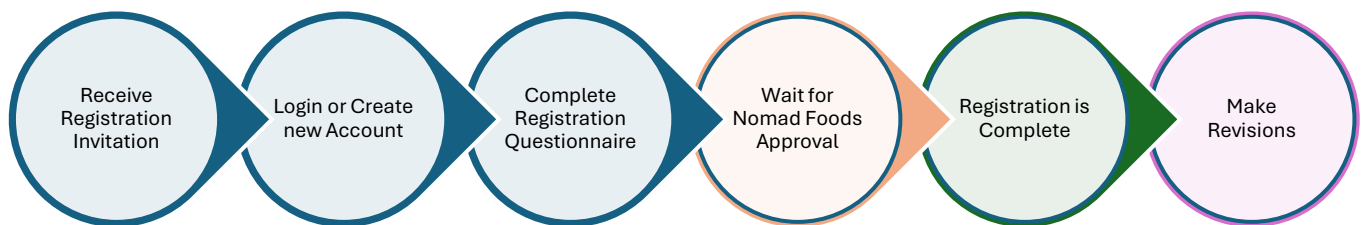
SLP simplifies our onboarding process and allows you to maintain your supplier data in our system. This new way of working gives you control over your data and reduces errors.

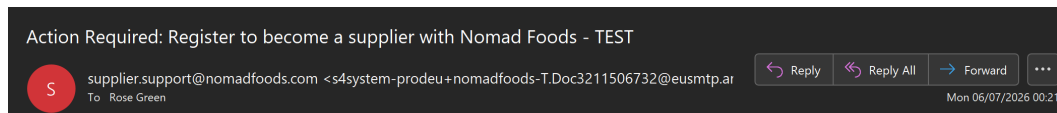

Supplier Onboarding Process

At Nomad Foods, we use SAP Ariba Supplier Lifecycle and Performance (SLP) to onboard our suppliers.



Step 1: You will receive an email invitation to register. Click on the **link** in order to access the questionnaire.

Step 1: Register a new account on SAP Business Network or if Microalgae oil for Demo have an existing SAP Business Network account, log in with your existing username and password. PLEASE NOTE, THIS IS A FREE ACCOUNT, and will allow you to submit your registration to us.

- [Click Here](#) to sign up or sign in. Please note this link has an expiration date (7 days), please ensure you complete the registration process before the link expires.

Step 2: Fill out and submit the Registration Questionnaire

(To prevent delays with your registration, please complete and submit your form within 7 business days, otherwise the form link will expire)

What happens after you submit the Registration Questionnaire?

- Once the registration questionnaire has been submitted, you will receive a confirmation email from Ariba notifying you of a successful submission. Your form will then go for approval to finalize the account registration.
- The Nomad Foods team will review your submitted questionnaire, please allow approximately 5 working days for a response. If additional verification for your submitted information is required, the Nomad Foods team will reach out to you. Please be on the lookout in case our team requests for additional information for the account registration.
- When the Nomad Foods team approves your registration, you will receive an 'Approved' email from Ariba. Once approved, the status of your application becomes 'Registered'.

Step 2: At this stage, it is very important that if your company has an SAP Business Network (SBN) account, it is linked instead a new account being created. You can:

- Verify internally and use **existing account** to login
- **Review the Accounts** that SBN has found to be likely your company
- **Create new account**, when you are certain this is the first time your company has used SBN. Merging duplicate accounts in SBN is a lengthy and difficult process, so it's worth checking before creating a new one.

Step 3: If you don't have access to the existing account, go to **Review Accounts** and **contact the administrator** of the most likely match(es).

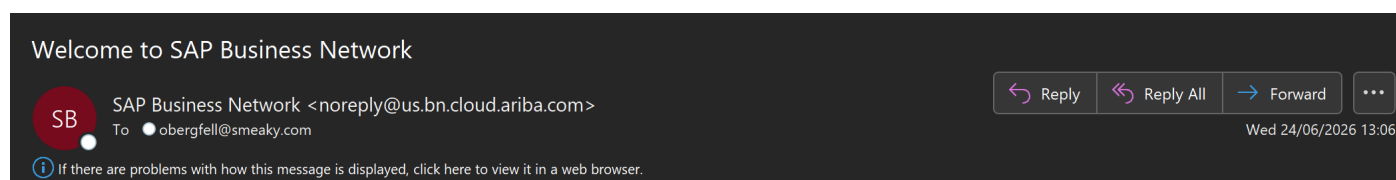
